## 2019 – 2020 FINANCIAL AID

Dear Parent/Guardians,

Kiddie Kampus is pleased to offer financial assistance to families in need. A limited amount of money for Kiddie Kampus Financial Aid is made available through private donations. These funds are awarded on a *first come, first serve basis; availability of funding; and the completed application (online or paper copy)*. Below are some general guidelines for Kiddie Kampus' Financial Aid Program:

<b>Due Date</b>	Scholarship applications must be received by <b>July 31, 2019</b> to be considered in first round of awarding funds (Committee meets in August)
<b>Selection Process</b>	Applications will be reviewed by the Kiddie Kampus Advisory Committee. This committee will use the table below, based on Federal Poverty Guidelines, for determining financial aid based on Annual Household Income and Household Size. The most recent Federal Poverty guidelines can be viewed at <a href="http://aspe.hhs.gov/poverty">aspe.hhs.gov/poverty</a>
<b>Expectations</b>	Students receiving financial aid are expected to attend school on a regular basis. <b>Excessive absences may result in the loss of money.</b>
<b>Confidentiality</b>	Names of students on financial aid and the amount of money awarded will be confidential, released only to the parents of the children and Kiddie Kampus treasurer.
